The Indenture of Bargain and Sale bearing date the Third Day of June in the year of our Lord one thousand eight hundred and Eleven, made between Lewis Hicks of the Township of Cross Town in the Incorporated Counties of Lenox and Addington in the Middle District and Province of upper Canada Yeoman and Farmer Hicks his wife of the one part, and Samuel Ware of the Township of Cross Town aforesaid District and Province aforesaid Yeoman of the other part, Purporting to be a Release of all that certain parcel or Tract of Land situate lying and being in the Township of Cross Town aforesaid in the Middle District and Province of Upper Canada, containing by admeasurement Five hundred acres of Land be the same more or less, being a portion of the said Township of Cross Town, which Five hundred acres of Land are better, and bounded, or may be otherwise, known as follows, that is to say commencing in front of the said Seventh Conception, at the South East angle of the said lot Number Twenty six. Then North Twenty four Degrees, Thirty minutes West, one hundred and five Chains, Twenty Seven links, Then South Sixty four Degrees, Thirty Minutes West, One hundred and five Chains, Twenty links, or less, to the place of beginning, Together with a dwelling House and Barn, thereon, with all woods, ways, waters, and water Courses with all and singular the Hereditaments Improvements and Appurtenances thereto belonging or in any way appertaining to have and to hold the said Tract or parcel

of land and Premises with the appurtenances unto the
Said Samuel Ward his heirs and assigns for ever
