A Memorial of an Indenture of Bargain Sale, dated the seventeenth day of January in the year of our Lord one thousand Eight hundred and forty two; Between Robert Harrison of the Township of Ernest Town in the Midland District and Province of Canada Yeoman, of the first part - and Jeremiah Snider of the Same place, Yeoman of the Second part - Wherein and whereby the said Robert Harrison for the Consideration of the sum of fifty five pounds of the lawful Money of the Province of Canada the receipt whereof is hereby acknowledged, hath and doth give Grant Bargain Sell Assign release transfer Convey and Confirm unto the said Jeremiah Snider his heirs and assigns all that certain parcel or tract of land situated in the Township of Ernest Town in the Midland District and Province of Canada containing by some measurement sixty acres, be the same more or less being a part of the Gore or Eighth Concession, of Ernest Town aforesaid, being bounded and bounded as follows that is to say commencing at the North East angle of Lot Number twenty six in the seventh Concession of Ernest Town, then North twenty four degrees thirty minutes West forty two Chains thirty eight links, more or less to the allowance for Road in front of the Township of Camden - thence westerly in the said allowance for Road eighteen Chains thirty links - thence South twenty four degrees thirty minutes East forty Chains sixty eight links to the Rear of the seventh Concession - thence North sixty five degrees thirty minutes East fifteen Chains eighty links more or less, to the place of Beginning - Excepting therefrom, however the less five acres of land from the said tract, heretofore conveyed by the said Robert Harrison to Nancy Moore to have and to hold the said Granted premises with all the privileges and Appurtenances thereof to him the said Jeremiah Snider his heirs and assigns to their own use forever - with Covenants of Seisin, Right to transfer freedom from incumbrances Quiet Enjoyment and General Warranty Subject however to the reservations and Conditions, contained in the Original Grant from the Crown -
